Graduate students have to complete the ethics course(s) administrated by the Center of Research Ethics Education (REE) at the online self-learning website, pass the related REE test(s), and then acquire the REE course certificate. For those departments and graduate institutes with other ethics course requirements established and enforced, such departmental or institutional ethics course requirements may supersede the REE course requirements.

If a Ph.D. student fails to defend their dissertation successfully but still hasn't been in the program longer than the allowed time, they may apply to defend again in the next semester or next academic year. They will be dropped from the graduate program upon a second failure. A score of 70 or higher is required to pass.
