Before applying for the thesis examination, the student must obtain a certificate of completion for the academic ethics education course. Each department (institute, degree program) determines eligibility for this. 2. After passing the PhD candidacy qualification assessment and completing the first draft of the research thesis, the student may apply for the thesis examination at least 20 days before the scheduled examination date after completing the registration and course selection for the semester. Graduate students may complete self-learning through the Taiwan Academic Ethics Education Resource Center website and must pass the final assessment to obtain a course completion certificate. If individual departments, institutes, or degree programs require additional professional academic research ethics training courses, students must comply with the specific regulations set by their respective programs. If a student fails the thesis examination but has not yet reached the maximum study period, they may apply for a retake in the following academic year or semester.
