<p>九、博士候選人資格考核：  研究生修完最低修業年限並修滿規定應修科目及學分，且撰妥學位論文計劃大綱及基本內容，始得提出博士候選人資格考核，並經考核委員會三分之二以上之委員通過，始為合格。  PhD candidates must have completed the minimum required years of study, fulfilled the required courses and credits, and prepared the thesis proposal outline and basic content before they can apply for the PhD candidacy qualification assessment. The assessment must be passed by more than two-thirds of the committee members to be considered qualified.</p>	<p>博士候選人資格考核不合格者，不得提出論文考試，經重考一次仍不合格者，予以退學。  PhD candidates who fail the candidacy qualification assessment cannot apply for the thesis examination. If they fail the re-examination once, they will be dismissed from the program.</p>												
<p>十、博士學位考試（論文考試）：  1. 研究生須於申請論文考試前取得學術倫理教育修課證明，前項資格由各系（所、學位學程）認定。  2. 通過博士候選人資格考核，並完成研究論文初稿者得於當學期完成註冊選課後，於預定舉行論文考試日期至少二十天前提出論文考試申請。論文考試成績以 70 分為及格。  <b>Doctoral Degree Examination (Thesis Examination):</b>  1. Before applying for the thesis examination, the student must obtain a certificate of completion for the academic ethics education course. Each department (institute, degree program) determines eligibility for this.  2. After passing the PhD candidacy qualification assessment and completing the first draft of the research thesis, the student may apply for the thesis examination at least 20 days before the scheduled examination date after completing the registration and course selection for the semester. A score of 70 or above is considered passing for the thesis examination</p>	<p>論文考試成績佔畢業成績 50%。  研究生得透過臺灣學術倫理教育資源中心網站自我學習，並通過總測驗取得修課證明；各系（所、學位學程）另訂有應通過專業學術研究倫理教育研習課程者，則依各系（所、學位學程）另訂之規定實施。  論文不及格而修業年限未屆滿者，得於次學年或次學期申請重考一次，重考仍不及格者，予以退學。重考及格者之成績，概以 70 分計算。  The thesis examination score accounts for 50% of the graduation grade.  Graduate students may complete self-learning through the Taiwan Academic Ethics Education Resource Center website and must pass the final assessment to obtain a course completion certificate. If individual departments, institutes, or degree programs require additional professional academic research ethics training courses, students must comply with the specific regulations set by their respective programs.  If a student fails the thesis examination but has not yet reached the maximum study period, they may apply for a retake in the following academic year or semester. If they fail the retake, they will be dismissed. If they pass the retake, their score will be recorded as 70 points.</p>

**Others:**

**Requirement of English proficiency:** None (If not specified by the department, this should be explicitly stated).

**Research report presentation:** During the study period, students are required to present research findings related to their thesis at least twice at relevant academic conferences and publish at least one research paper related to their thesis as the first author in an SCI journal or SSCI journal.

Students must complete the doctoral candidacy qualification assessment within three years of study.
